

Purchase Green Artificial Ivy Limited Warranty

This is to certify that Purchase Green products are produced under strict management. We offer a warranty of 5 years if the solar activity range is 0-200W/M2 and a 3-year warranty on all other components of the product.

- Anti-UV colors may not significantly fade away within 5 years.
- Anti-aging, leaves may not fall within 3 years, frame may not be broken within 3 years.

If any quality problems occur during the warranty period, the customer must offer effective evidence (such as photos, videos, samples, etc.), and Purchase Green will be responsible for relevant compensation under the terms of the "Purchase Green Product Warranty – Artificial Ivy".

Limited Warranty

Purchase Green (hereinafter referred to as "PG"), warrants to the person, firm, or entity purchasing, that under normal conditions, PG Artificial Ivy will be warranted against manufacturer defects, including improper molding, wrong sizes, or large areas of premature cracking which cause the products to be unserviceable due to strength loss from normal usage and exposure conditions, including sunlight and mildew.

Limitations on Coverage

This warranty is inapplicable to damages from improper care and cleansing, misuse, abuse, or improper installation which includes, but is not limited to the following:

- Burns, cuts, accidents, vandalism, abuse, negligence, or neglect.
- Improper design or failure of the sub-base.
- Any corrosive or other chemicals.
- High pressure or high mineral content water sprays or sprinkles.
- Failure to properly maintain, protect, or repair the Products.
- Forces of nature: high wind, sands to rms, or other sources not related to the initial manufacturing.

Limitation of Liability

PG's liability for any defective product shall not exceed the purchase price for the defective products. PG shall in no event be held liable, whether on the basis of contract or tort (including, but not limited to, negligence) or under any other legal theory (including, but not limited to, strict liability and/or equitable theory), for lost profits or revenues, loss of use or similar economic losses, or for indirect, special, incidental, consequential, punitive or similar damages arising from or in connection with the use, conditions, possession, performance, maintenance, non-delivery or late delivery of the products, even if PG has been notified of the possibility of such damages.

Modifications

This warranty and PG's standard terms and conditions of sale are the complete, final, and exclusive agreement of the parties with respect to the quality and performance of the products and all warranties concerning the products. No dealer, sales representative, or similar person is authorized to grant warranties which are not covered by this warranty, to extend any warranty period hereunder or otherwise to change, modify, amend, or supplement the provisions of this warranty. Any change, modification, or supplement to this warranty must be made in a written instrument signed by an authorized representative of PG.

Waiver

PG's failure to exercise or delay in exercising any right, power, or remedy hereunder shall not be considered as a waiver thereof. No single or partial exercise of any right, power, or remedy by PG precludes any other or further exercise thereof or the exercise of any other right, power, or remedy.

Severability

If any provision or any portion of any provision of this warranty be held to be illegal, invalid, or unenforceable by a competent judicial court, the remaining provisions or portions thereof shall remain in full force and effect and shall remain to be a binding agreement of the parties with respect to the subject matter hereof.

Assignment

Without PG's advance written consent, the Purchaser may not transfer, convey, or otherwise assign all or any of its rights under this warranty. This warranty is to benefit and be binding upon PG and the Purchaser and their respective successors and authorized assignees. Claims under this warranty may only be made by the Purchaser and not by the Purchaser's sub-buyers or any other third parties.

PG shall not be held to bear any costs or expenses incurred by the Purchaser or others regarding any tests, inspections or consultations carried out by the Purchaser or others.
